190.408: Advanced Readings in Middle East History and Politics (Spring 2009)

Intensive readings on Middle East topics; including Islamic history, Arab and Iranian political thought, political Islam, nationalism and political identity, and US policy in the region. This seminar is intended for advanced undergraduates and graduate students to explore and discuss issues, themes, and readings introduced in 190.311 and 190.346.

Prerequisites: 190.311 (Middle East Politics) or 190.346 (US in the Middle East) or Perm. Req'd

Requirements:

- 1. Informed and engaged participation in weekly seminar (20% of grade)
 - I will take attendance. I allow one missed session with no penalty, no questions asked. Beyond that missed classes impact your grade a bit. I do not care to hear excuses (except for severe physical or mental illness to you or family member). You can only make up additional missed sessions (max of 2) through active participation in the sessions you do attend. I expect everyone to have read the material *thoroughly*. I will often ask students direct questions about the reading (and allow a one-time-only "didn't have time for the reading" pass).
- **2. In-class presentation** (about 5-10 mins) about one of the week's reading (5%) Presentation will begin 2nd hour of seminar. Your task it to present critique or critical reading of one or more of week's readings and suggest questions for class discussion. If you have a handout, you can email it to me by noon to make copies for the class.
- **3. Three 5 page critical review essays** (15% each), Choose any 3 sessions, but must write 1st paper by Feb 25. The paper is not a summary of reading, but a critical evaluation of important/interesting claims. The paper is due at 4pm the Wednesday after seminar in my mailbox 338 Mergenthaler. You are free to rewrite paper for better grade (but are expected to make substantial improvements or write more than 3 and I will count 3 highest marks. Please see "Notes on Writing" handout.
- **4. Undergraduates**: **15-20 page review essay,** can be expansion of a review papers. Due May 8 (30%) Paper must focus on a central question or issue through a critical examination of one or more of the course texts. It may draw on relevant outside readings, such as reviews and critiques or other related readings.
 - **Graduate students: 20-25 page critical review essay** or **research paper**, due May 8. Paper may address Middle East topics beyond those covered in seminar. In any case, paper should engage relevant literature relating to topic.
